Roy Weatherwax seconded the motion to add 480-658 to the already existing 480-458 *Collaboration for Effective Instruction*. After a short explanation by Diane Ormsby, the addition was approved.


A Roy Weatherwax motion and Jim Winship second grouped and requested approval of the 'information only' items. The four items were approved without question. The items to be received and recorded are:

1. Requisite Change in course from Department of Educational Foundations - 424-740 *Techniques of Research*-change the requisite from *Restricted to Students with Curric: MS-Couns-Guid* to *Restricted to Students with Curric: MS-Coun-Guid and/or MSE Special Education*.
2. Requisite Change in course from Department of Curriculum and Instruction - 434-361/561 *Children's Literature* - change the requisite from *Restricted to Students with Major: Elementary Education, PK-6 or minor, Library Media K-12 and Professional Education Admission;* to *Restricted to Students with Major in Elementary Education, PK-6 or a major in Special Education: EEN or a minor in Library Media K-12 and Professional Education Admission*.


3. Number Change in course from Department of Communicative Disorders - change course number from 439-793, *Communicative Disorders Practicum* to 510-793.
4. Number Change in course from Department of Communicative Disorders – change course number from 436-798 *Communicative Disorders Practicum* to 510-798.

A motion by Rick Lombard to adjourn was made at 3:01 p.m. The meeting ended as Bill Chandler seconded the motion.
