II. **Justification for action**

While the DPI has applauded our series of courses leading to the Alternative Education Programs Licensure (952), the number of credits required (15 total) has been prohibitive to students wishing to obtain the 952 license. We are in the process of converting the course to an on-line format and have taken this opportunity to reconfigure the AEPL Program to a series of four 2-credit courses that can be completed within one academic year or one summer. We have also taken this opportunity to rename the courses in hopes of making them more marketable by making the titles more reflective of the actual content and thus more readily accessible to teachers in the field.

This course will be offered in the second eight weeks of each fall semester and during the second three-week term of each summer session.
